

National Honor Society Northeast Metro Tech Artisan's Chapter Bylaws

Article I: Name and Purpose

Section 1- The name of this chapter shall be the Northeast Artisan's Chapter of the National Honor Society of Northeast Metropolitan Regional Vocational Technical High School.

Section 2- The purpose of this chapter shall be to create enthusiasm for scholarship; to stimulate a desire to render service; to promote leadership; and to develop strong character in the students.

Article II: Membership

Section 1- Membership in this chapter shall be known as active, honorary, and graduate.

Active members become graduate members upon graduation.

Section 2- Membership in this chapter is an honor bestowed upon deserving students by the faculty, and shall be based on the criteria of scholarship, service, leadership, and character.

Section 3- Eligibility

- a. Candidates who are eligible for election to the Northeast Artisan's Chapter must be members of the sophomore, junior, or senior class.
- b. To be eligible for selection to membership in this chapter, the candidate must have been in attendance at Northeast Metropolitan Regional Vocational Technical High School for a period of one semester or longer.
- c. Candidates eligible for selection to the Northeast Artisan's Chapter shall have a minimum cumulative GPA of 3.7 (out of a 4.0 grading scale or an A- [90%]). In addition, once a candidate becomes a member, the member shall not receive any GPA lower than 3.7 during any term while currently a member. This scholastic level of achievement shall remain fixed, and shall be the required minimum level of scholastic achievement for consideration of candidacy. All students who rise in scholarship to or above such standard may be admitted to candidacy for selection to membership.
- d. Upon meeting the grade level, attendance, and GPA standard requirements, candidates shall then be considered based upon their service, leadership, and character as aforementioned.

Article III: Selection of Members

Section 1- The selection of members to the Northeast Artisan's Chapter shall be by a majority vote of the Faculty Council consisting of five faculty members appointed by the advisor. The chapter advisor shall be the sixth, nonvoting, ex officio member of the Faculty Council.

Section 2- Prior to selection, the following shall occur:

- a. Students' academic and non-excused attendance records shall be reviewed to determine scholastic eligibility.

b. Students who are eligible scholastically (now “candidates”) shall be notified by written notification and asked to complete and submit the Student Activity Information Form for further consideration.

c. The faculty shall be requested to assist in evaluating candidates determined to be scholastically eligible using the official evaluation form provided by the chapter advisor.

d. The Faculty Council shall review the Student Activity Information Form and the faculty evaluations in order to determine membership.

Section 3- The selection of new active members shall be held during the first Semester of the subsequent school years after the selection of members in the Inaugural year.

Section 4- Candidates become members when inducted at a special ceremony.

Section 5- Once selected and inducted, all members are expected and required to maintain the standards by which they were selected and maintain all obligations of membership.

Section 6- An active member of the National Honor Society who transfers from this school will be given a letter indicating the status of his or her membership and signed by the principal or the chapter advisor.

Section 7- An active member of the National Honor Society who transfers to this school will be automatically accepted for membership into the Northeast Artisan’s Chapter. The Faculty Council shall grant the transferring member one semester to attain the membership requirements and, thereafter, this member must maintain those requirements in order to retain his or her membership.

Article IV: Discipline and Dismissal

Section 1- Any member who falls below the standard of scholarship, leadership, character, or service may be considered for dismissal from the Northeast Artisan’s Chapter of the National Honor Society. A member of the National Honor Society is expected and required to maintain his or her academic standing, take an active role in service and leadership to his or her school and community, and to exhibit positive character traits.

Section 2- If a member’s cumulative GPA falls below the standard in effect of 3.3 without having failed classes after he or she was selected, he or she will be given a written warning and one term to restore their record to required standards. If the cumulative GPA and grades issued per class remain below the set standard at the end of the warning period (one term), the student will be subject to further disciplinary action by the Faculty Council which may include dismissal from the chapter.

Section 3- If a member fails to perform any of the published obligations of membership, he or she will be given written warning and a time period for improvement. If the obligation remains unmet at the end of the warning period, the student will be subject to further disciplinary action by the Faculty Council, which may include dismissal from the chapter.

Section 4- Violation of the law or school regulations can result in immediate dismissal of a member. These violations include, but are not limited to, DWI; stealing;

assault; destruction or vandalism of property; possession of any type of weapon on school property; possession, selling or being under the influence of illegal drugs or alcohol, truancy; bullying, or cheating.

Section 5- Offenders of the school conduct code (such as use of profanity, failure to comply, unexcused absences, excessive tardiness, dress code infractions, etc) will receive written warning/ notification. A conference may be requested by either party (Faculty Council, student, or parent). If the member is involved in another violation of the school conduct code, the member may be considered for dismissal from the chapter.

Section 6- In all cases pending dismissal:

- a. The member will receive written notification indicating the reason for possible dismissal from the advisor or Faculty Council. The member and advisor will discuss the written notification in a conference. Situations that involve flagrant violations of school rules or the law can warrant disciplinary action without a written warning although a hearing must still be held.
- b. The member will be given the opportunity to respond to the charge against him or her at a hearing before the Faculty Council prior to the vote on dismissal. The Faculty Council will then vote on whether to dismiss the member.
- c. The results of the Faculty Council vote will be reviewed by the principal then, if confirmed, expressed in a letter sent to the student, parents, and or guardian. Dismissed members must surrender any membership emblems to the advisor.
- d. The Faculty Council's decision may be appealed to the school principal and afterwards through the school's discipline policy.
- e. When a student is dismissed for any reason, he or she is no longer a member and may not be reconsidered for membership in the National Honor Society. If a student independently resigns from the National Honor Society, he or she may not be reconsidered for future membership in the National Honor Society.

Section 7- In lieu of dismissal, the Faculty Council may impose disciplinary sanctions upon a member as deemed appropriate.

Article V: Officers

Section 1- The officers of the chapter shall be president, vice president, secretary, and treasurer.

Section 2- Student officer candidates shall be elected at the initial meeting of each school year. All returning active members are eligible to run for a position as an officer. All active members of the chapter are eligible to vote.

Section 3- A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

Section 4- The following duties shall reflect the responsibilities developed for officers in the Northeast Artisan's Chapter.

- a. It shall be the duty of the president to preside over the meetings for the

Northeast Artisan's Chapter.

b. The Vice President shall preside in the absence of the president and shall also keep a record of members' contributions to leadership and service.

c. The secretary shall keep the minutes of meetings and be responsible for all official chapter correspondence.

d. The treasurer shall keep the record of chapter expenses, dues, and all other financial transactions of the Northeast Artisan's Chapter.

Section 5- In the case that a student officer is unable to complete his or her duties due to a dismissal, resignation, or student withdrawal from Northeast Metropolitan Regional Vocational Technical High School, the student will need a replacement appointed by the remaining officers.

Article VI: Executive Committee

Section 1- The executive committee shall consist of the faculty advisor and the chapter officers.

Section 2- The executive committee shall have general charge of the meetings and the business of the chapter, but any action by the executive committee is subject to the review of the chapter members.

Article VII: Meetings

Section 1- Meetings of all Northeast Artisan's Chapter members shall be conducted once per month (This may subject to change). All members will be notified of upcoming events and meetings at least one week in advance.

Section 2- All chapter members are expected to attend all regularly scheduled chapter meetings.

Section 3- Absentees at chapter meetings may be subject to disciplinary action or dismissal decided upon by the Faculty Council. Acceptable excused absences are

a. Illnesses confirmed with a note from a parent and or guardian as well as a doctor.

b. Any medical appointments confirmed with a doctor's note.

c. School sponsored activities such as sports (games only), field trips, conferences, etc.

Article VIII: Activities

Section 1- The Northeast Artisan's Chapter shall determine one or more service projects for each year.

Section 2- All members are required to regularly participate in these projects. If a member chooses not to participate, disciplinary action may be taken which may include dismissal from the Northeast Artisan's Chapter.

Section 3- These projects shall have the following characteristics: fulfill a need within the school or community; have the support of the administration and the faculty; be appropriate and educationally defensible; and be well planned, organized, and executed.

Section 4- Each member shall have the responsibility for choosing and participating in an individual service project that reflects his or her particular talents and interests and

as approved by the chapter advisor. This is in addition to the chapter projects to which all members shall contribute.

Section 5- The Northeast Artisans' Chapter shall publicize its projects in a timely and positive manner.

Article IX: Emblem

Section 1- Each member of this chapter who is in good standing with regard to the membership standards and obligations shall have the privilege of wearing the emblem adopted by the National Honor Society.

Section 2- Any member who withdraws, resigns, or is dismissed from the Northeast Artisans Chapter shall return the emblem of the chapter. If a member has purchased items including the emblem on their own, those items are still required to be surrendered to the Northeast Artisan's Chapter and that student shall be reimbursed for those items if proof of cost is presented to the Faculty Council or principal.

Section 3- Chapter members who are seniors in good standing shall be granted the privilege of wearing the honor cords or other insignia adopted by Northeast Artisan's High School at their graduation ceremony.

Article X: Dues

Section 1- There shall be no annual dues to become a member of the Northeast Artisans Chapter of the National Honor Society.

Section 2- In the future, if a membership due is required, fees will be payable to Northeast Artisan's Chapter of The National Honor Society and will be reported to the chapter treasurer to keep current records of.

Article XI: Powers

Section 1- The chapter advisor is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

Section 2- The principal shall reserve the right to approve all activities and decisions of the chapter.

Section 3- These bylaws are designed to amplify provisions of the national constitution of the National Honor Society and cannot contradict any components thereof. The Northeast Artisan's Chapter is obligated to adhere to the provisions of the national constitution in all activities that it undertakes.

Article XII: Amendments

Section 1- These bylaws may be amended by a two-thirds vote of the chapter, provided that notice of the proposed amendment has been given to members at least one month prior to the vote. The exceptions are Articles III and IV (selection and discipline), which are developed by the Faculty Council with the approval of the principal.

Section 2- Bylaws and amendments must be consistent with the constitution of the National Honor Society.
